- The factory production control (FPC) has passed the required stipulations and is also inspected by MFPA Leipzig GmbH at regular intervals.

I. MFPA Leipzig GmbH quality seal for products



In combination with test reports, this quality seal confirms that the product has been manufactured in accordance with applicable European standards and satisfies all of the requirements of these standards.

II. MFPA Leipzig GmbH quality seal of the factory production control



MFPA Leipzig GmbH inspected your factory production control at regular intervals and certifies your positive compliance with all of the stipula-tions. In addition to symbols that are relevant for building regulations, you can advertise with the "Inspected Quality" seal and convince your customers of the constant quality of your production.

Conditions for use

The quality seal does not replace any statutory mark of conformity such as the CE or Ü mark. Nor is it a mark that approves the product for a par-ticular use.

The use of the quality seal issued by MFPA Leipzig GmbH on the product, in leaflets, brochures, on the Internet or similar media is allowed if these are directly connected to the tested/inspected product of the factory production control. No changes may be made to the content; the size can be changed at will.

Furthermore, it is imperative that the product is manufactured/inspected in accordance with national/European standards and can be proven to satisfy all of the requirements of these standards through testing/inspection at MFPA Leipzig GmbH.

The general use (e.g. on business stationery) without a direct reference to the tested/ inspected product named on the quality seal is forbidden.

The validity of the MFPA Leipzig GmbH quality seal is compulsorily linked to the validity of the results report or the inspection contract, though it expires after a maximum of 5 years. On the date of expiry of the report/termination of the contract

a) the quality seal has to be immediately removed from all of the aforementioned media, or

b) the authorisation to use the quality seal in advertising can be extended on application.

MFPA Leipzig GmbH can forbid the use of the quality seal or stipulate further conditions for its use at any time. There is no legal entitlement to an issue of the MFPA Leipzig GmbH quality seal. In addition, the GTC of MFPA Leipzig GmbH, which can be downloaded from the aforementioned website, also apply.
